## INCREASING TRUST IN CLOUD WITH CONTINUOUS AUDITING

Third party audits and certifications provide assurance on the reliability of security and privacy measures implemented by Cloud Service Providers. However, once or twice yearly audits don't deliver the reassurance required by businesses in heavily regulated sectors, such as finance and health care, and therefore remain a barrier to cloud adoption.

Continuous audit based certification is the regular production of statements indicating that an IT system meets its regulatory objectives. This concept drives EU-SEC's work in this area and is the basis for the Continuous Auditing Pilot.

EU-SEC's continuous auditing changes the nature of auditing from a traditional, process-driven, point-in-time certification towards a data-driven real-time certification.

Thanks to the expertise of partner CaixaBank, the EU-SEC project is well placed to understand the requirements of the finance industry and address their needs in the pilot architecture.
